I hereby take the following action for myself, my executors, administrators, heirs, next of kin, successors and assigns:

- a) I WAIVE, RELEASE, AND DISCHARGE the NAMED PERSONS OR ENTITIES listed below from any and all claims or liabilities for damages or claims of any kind, including, without limitation, any claims for death, injury, disability or property damages, that arise out of or relate to participation with the Jupiter Volleyball Club (a/k/a "Jupiter Elite"), including, without limitation, tournaments, training and traveling to/from tournaments and training, use of facilities and equipment.
- b) I AGREE NOT TO SUE any of the NAMED PERSONS OR ENTITIES listed below for any of the claims or liabilities that I have waived, released or discharged herein;

- d) I EXPRESSLY UNDERSTAND that the foregoing waiver and release includes any claims based upon the negligence, action or inaction of any of the NAMED PERSONS OR ENTITIES.
